11 NRS Ch. 432B Confidentiality

14 The Ninth Judicial District Court hereby authorizes a party, or attorney representing the party,
15 access to the formal court record of a specific NRS Ch. 432B proceeding in which the party is named.
16 Ninth Judicial District Court Rule 32.5 prevents all users of the Ninth Judicial District Court Electronic
17 Filing System from viewing confidential documents without a court order issued in advance of viewing.
18 “In conducting a proceeding held pursuant to NRS 432B.410 to 432B.590, inclusive, . . . a judge or
19 judicial officer shall keep information confidential to the extent necessary to obtain federal funds in the
20 maximum amount available to this state.” NRS 432B.430(4).


22 This order does not waive the confidentiality of the information received as a result of this
23 order. *See* NRS 432B.280(1-2). Any confidential information obtained as a result of this order shall
24 continue to be confidential and continue to be maintained in a confidential manner. “No person in
25 possession of a confidential electronic record may release the information to any other person unless
26 provided by law.” NEFCR 14(b).


1 The sole purpose of this order is to provide a party to the NRS Ch. 432B action, or attorney
2 representing the party, access to the electronic court record of that matter only.¹ This order does not
3 waive or dissolve any other confidentiality requirement regarding records of a NRS Ch. 432B
4 proceeding in any way nor satisfy any requirement to provide a parent, guardian, or their attorney with
5 a copy of a report or information submitted to the court for consideration, *see, e.g.*, NRS 432B.513(1).
6 Any information or document, received as a result of this order, which is burdened with a separate or
7 additional confidentiality requirement is not to be disseminated without a separate written order or
8 specific statute authorizing further dissemination; for example, without limitation *see* NRS 432B.290.

9
10 In addition to the parties to a case and their attorneys, the Manager of Court Advocacy Programs
11 for the Ninth Judicial District Court, as well as an assigned representative from the Division of Child
12 and Family Services for the Nevada Department of Health and Human Services, are also authorized to
13 access the same formal court record of any NRS Ch. 432B proceeding.
